

Official Rules

This Giveaway (“Giveaway”) is sponsored by Vote Save America, a 527 nonprofit organization under the Internal Revenue Code that is registered as a hybrid political committee with the Federal Election Commission, with an address of c/o Hansen Jacobson et al., 450 N Roxbury Dr #800, Beverly Hills, CA 90210, United States, Attn: Adam Kaller, Esq. and Ryan Pastorek, Esq. (“VSA”), and is open only to legal residents of the United States, excluding Rhode Island (“Eligibility Area”), and shall be construed according to, and governed exclusively by, U.S. law. You may not participate in the Giveaway unless you meet the eligibility requirements set forth below and are a legal resident physically located in the United States at the time of entry.

GIVEAWAY DESCRIPTION

The Giveaway begins on July 16, 2026 at 7:00 AM ET and ends on August 1, 2026 at 11:59 PM ET, or when all Prizes have been awarded, whichever occurs first (the “Giveaway Period”). Winners will be selected on a rolling basis as entrants successfully complete the entry requirements, until all one hundred (100) Prizes have been awarded. Winners will be notified within a reasonable period after selection. You acknowledge that dates for such Giveaway Period are subject to change in VSA’s sole discretion. Prizes will be awarded to the first one hundred (100) entrants who complete the entry requirements described below (each, a “Winner”). By participating in the Giveaway, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules as follows:

ELIGIBILITY

NO PURCHASE OR PAYMENT IS NECESSARY IN ORDER TO ENTER THE GIVEAWAY. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

Only legal residents of the Eligibility Area who are eighteen (18) years of age and older are eligible to enter. This Giveaway is a civic engagement promotion designed to encourage participation in nonpartisan voter education and civic engagement activities. This Giveaway is not connected to voter registration, voting, or any specific candidate for public office. Participation in this Giveaway does not require any political contribution, and no portion of any contribution to VSA will be used to fund the Prizes in this Giveaway.

ENTRIES

Entries are captured through submissions to VSA as follows:

1. To enter, an entrant must successfully refer five (5) new subscribers to the Vote Save America email list by sharing their unique referral link with friends who then sign up using that link (“Referral Requirement”). Entrant must complete the entry form at <https://votesaveamerica.com/forms/book-giveaway/> to receive their unique referral link. Each referred subscriber must affirmatively consent to receive email communications from VSA; referrals of individuals who do not provide such consent will not count toward the Referral Requirement.
2. Once an entrant’s five (5) referrals have been verified and the entrant is among the first one hundred (100) qualifying entrants, the entrant will be notified as a Winner.

VSA is not responsible for incomplete, illegible, misdirected, late, lost, damaged, or stolen entry

submissions, which may be judged void. Entries by any method other than those set forth above are void. Limit one (1) entry per person and/or household, regardless of the method of entry. Referred subscribers must be unique individuals and may not be referred by more than one entrant. Self-referrals are void. Proof of entry, regardless of method of entry, is not considered proof of delivery to or receipt by VSA of an entry for this Giveaway. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to VSA's satisfaction, the affected entry will be deemed ineligible.

By submitting any entry, participant agrees that participant's disclosure is gratuitous, unsolicited and without restriction and will not place VSA under any fiduciary or other obligation, that VSA is free to disclose the entry on a non-confidential basis to anyone or otherwise use the entry, including, without limitation, in connection with merchandise, without any additional compensation to participant. Participant acknowledges that, by acceptance of participant's entry, VSA does not waive any rights to use similar or related ideas previously known to VSA, or developed by its employees, or obtained from sources other than you.

By sending or transmitting to VSA any entry, participant hereby grants to VSA and its designees a worldwide, non-exclusive, sublicensable, assignable, royalty-free, perpetual, irrevocable right to use, reproduce, distribute, modify, create derivative works of, publicly perform, publicly display, digitally perform, sell, offer for sale and import such entry in any media now known or hereafter devised, for any purpose whatsoever, commercial or otherwise, without compensation to participant. The foregoing license to VSA shall be fully paid-up and royalty free. Participant represents and warrants that any person or entity named or pictured in such entry has provided any necessary licenses, rights or authorizations to allow VSA's use of such entry in accordance with such license. None of the entries disclosed or posted via message boards, chats or other public forums shall be subject to any obligation, whether of confidentiality, attribution or otherwise.

WINNER SELECTION AND NOTIFICATION

Winners will be selected on a first-come, first-served basis. The first one hundred (100) entrants to successfully complete the Referral Requirement during the Giveaway Period will be declared Winners. Winners will be selected on a rolling basis as each entrant successfully fulfills the entry requirements. Winners will be notified via email within a reasonable period after selection using contact information provided with their Giveaway entry. VSA shall have no liability for any Winner notification that is lost, intercepted or not received by a potential Winner for any reason. If, despite reasonable efforts, a potential Winner does not respond within seventy-two (72) hours of the first notification attempt, or if the Prize or Prize notification is returned as unclaimed or undeliverable to such potential Winner, such potential Winner will forfeit his or her Prize and the next qualifying entrant may be selected as an alternate Winner. If any potential Winner is found to be ineligible, or if he or she has not complied with these Official Rules, or declines the Prize for any reason prior to award, such potential Winner will be disqualified and the next qualifying entrant may be selected as an alternate Winner.

DESCRIPTION OF PRIZE / ODDS

PRIZE: One hundred (100) Winners will each receive one (1) copy of the book *This Is The Plan: How to End America's Meltdown and Save Democracy* written by Ben Wickler (approximate retail value: \$29.99).

Because this Giveaway is awarded on a first-come, first-served basis, the odds of winning depend

on how quickly entrants complete the Referral Requirement relative to other participants.

GENERAL PRIZE CONDITIONS

Prizes will be awarded only if the potential Winner fully complies with these Official Rules. Prizes are nonassignable and nontransferable. All details and other restrictions of prizes not specified in these Official Rules will be determined by VSA in their sole discretion. No cash alternative or substitution will be allowed, except VSA reserves the right in their sole discretion to substitute prize(s) of comparable value if the Prize is unavailable, in whole or in part, for any reason. EACH WINNER SHALL BE SOLELY RESPONSIBLE FOR ALL FEDERAL, STATE AND/OR LOCAL TAXES, AND THE REPORTING CONSEQUENCES THEREOF, AND FOR ANY OTHER FEES OR COSTS (INCLUDING INSURANCE) ASSOCIATED WITH THE APPLICABLE PRIZE. Potential Winners may be required to execute an Affidavit of Eligibility, a Liability Release, and (where legal) a Publicity Release (collectively, "Prize Claim Documents"). WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, PRIZES ARE PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, AND VSA HEREBY DISCLAIMS ALL SUCH WARRANTIES, INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND/OR NON-INFRINGEMENT AND/OR THE APPROXIMATE VALUE OF ANY PRIZE.

GENERAL LIABILITY RELEASE/FORCE MAJEURE

Acceptance of the Prize constitutes Winner's permission for VSA to use Winner's name, photograph, likeness, voice, biographical information, statements and address (city and state). Ben Wickler, the author of the Prize book, is not a sponsor of the Giveaway, has no financial arrangement with VSA in connection with this Giveaway, and is not related to this Giveaway in any way. The Prize book is being provided by VSA independently and Mr. Wickler's role as Chair of the Wisconsin Democratic Party is unrelated to this Giveaway. By participating or accepting the Prize, Winner hereby releases, discharges and covenants not to sue VSA, and any of their affiliates, subsidiaries, predecessors, successors in interest, assigns, officers, directors, shareholders, employees and agents, past and present, in any and all capacities (collectively, "Released Parties"), in respect of any and all claims, damages, charges, injuries, losses, proceedings, suits, actions (including, but not limited to, tort actions, product liability actions, wrongful death actions, warranty actions, breach of contract actions, privacy and defamation actions, misappropriation of likeness actions, loss of consortium claims, etc.), expenses and attorney fees ("Claims") that Winner or anyone on Winner's behalf (including, but not limited to, Winner's heirs, representatives or next of kin) have or might have for any death, injury, damage or claimed injury or damage, arising out of, involving or relating to Winner's participation in the Giveaway, including, but not limited to, any claim that the act or omission complained of was caused in whole or in part by the strict liability or negligence in any form of the Released Parties (including use of the Prize). VSA reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Giveaway, to be acting in violation of these Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Giveaway, or to annoy, abuse, threaten or harass any other person, and VSA reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law. No mechanically reproduced, illegible, incomplete, forged, software-generated or other automated multiple entries will be accepted. VSA reserves the right to modify, extend, suspend or terminate the Giveaway if it determines, in its sole discretion, that the Giveaway is technically impaired or corrupted or that fraud or technical problems, failures or malfunctions or other causes beyond VSA's control have destroyed or severely undermined or to any degree impaired the integrity, administration, security, proper play and/or feasibility of the Giveaway as contemplated herein. In the event VSA is prevented from awarding Prizes or continuing with the Giveaway as contemplated herein by any event beyond its control, including but not limited to fire, flood, natural or man-made epidemic of health or other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal, state or local government law, order, or regulation, public health crisis (e.g., SARS), order of any court or jurisdiction, or other cause not reasonably within VSA's control (each a "Force Majeure" event or occurrence), then VSA shall have the right to modify, suspend, or terminate the Giveaway. If the Giveaway is terminated before its designated end date, VSA will not be required to award Prizes to any entrants. These Official Rules cannot be modified or amended in any way except in a written document issued in accordance with law by a duly authorized representative of VSA. The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.

GOVERNING LAW/JURISDICTION

ALL ISSUES AND QUESTIONS CONCERNING THE CONSTRUCTION, VALIDITY, INTERPRETATION AND ENFORCEABILITY OF THESE OFFICIAL RULES OR THE RIGHTS AND OBLIGATIONS OF ENTRANTS OR VSA IN CONNECTION WITH THE GIVEAWAY SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE INTERNAL LAWS OF THE STATE OF CALIFORNIA WITHOUT GIVING EFFECT TO ANY CHOICE OF LAW OR CONFLICT OF LAW RULES OR PROVISIONS THAT WOULD CAUSE THE APPLICATION OF ANY OTHER STATE'S LAWS.

ARBITRATION PROVISION

By participating in this Giveaway, each entrant agrees that any and all disputes the entrant may have with, or claims entrant may have against, VSA relating to, arising out of or connected in any way with (i) the Giveaway, (ii) the awarding or redemption of the Prize, and/or (iii) the

determination of the scope or applicability of this agreement to arbitrate, will be resolved individually and exclusively by final and binding arbitration administered by JAMS (the "Forum") and conducted before a sole arbitrator pursuant to JAMS Streamlined Arbitration Rules. The arbitration shall be held in Los Angeles County, California. The arbitrator's decision shall be controlled by the terms and conditions of these Official Rules and any of the other agreements referenced herein that the applicable participant may have entered into in connection with the Giveaway. There shall be no authority for any claims to be arbitrated on a class or representative basis; arbitration can decide only the participant's and/or VSA's individual claims and the arbitrator may not consolidate or join the claims of other persons or parties who may be similarly situated. The arbitrator shall not have the power to award punitive damages against the participant or VSA. If any part of this Arbitration Provision is deemed to be invalid or otherwise unenforceable or illegal, the balance of this Arbitration Provision shall remain in effect and shall be construed in accordance with its terms as if the invalid or illegal provision were not contained herein.
